TUITION PACKET FACT SHEET

1.1 Tuition and Enrollment Periods

Starting in the 2010-2011 school year, Grace Christian Academy defines Tuition to include the costs of the following items: teachers, administration, curriculum, books, maintenance and other school related items and services.

Tuition for the 2010-2011 School Year is as follows:

\$3650	Kindergarten	(8:30AM – 12Noon)
\$4450	First-Sixth Grades	(8:30AM – 3:05PM)
\$4700	Seventh – Eighth Grades	(8:25AM – 3:05PM)

Enrollment Periods for 2010-2011 School year are as follows:

- **Early Enrollment:** ends April 22, 2010 (In future years, the early enrollment period will end in March.)
10% tuition down payment
- **Late Enrollment:** after April 22, 2010
5% tuition down payment
\$500 Late Enrollment Fee
- Note: Tuition down payments and any late fees are non-refundable.

1.2 Tuition Discounts:

- **3% Prepayment Discount:** A 3% Prepayment Discount will be given to those who prepay the entire year's tuition on or before June 1st. This payment will be made directly to Grace Christian Academy. This discount is applied before any other. One of the following may also apply.
- **30% Multiple Child Discount:** A 30% tuition discount will be given to families with more than one child enrolled in Grace Christian Academy during the same school year. The child in the highest grade must be enrolled at full tuition. This discount is applied to each additional child enrolled during the same school year.

- **25 % Full time Christian Workers' Discount:** A 25% tuition discount will be given to families where at least one parent is a full time Christian worker. A "full time Christian worker" is defined as one who is employed full time by a recognized Christian organization. This discount is specifically created for full time pastors of Christian churches and full time Christian missionaries. This discount may be applied to other full time Christian workers as approved by the Grace Christian Academy School Board.

1.3 Tuition Payments:

All families shall be expected to make tuition payments according to one of the following payment plans. Each family's preferred manner of payment must be submitted each year at the time of student enrollment. Options for payment shall include:

- Full Payment:** Under this plan, the entire amount of tuition is paid on or before June 1st and entitles you to a 3% discount. This payment is made directly to the school office.
- Monthly Payments:** Under this plan, the outstanding tuition balance is paid monthly over a ten (10) month period beginning in August through the FACTS Tuition Management Plan. This plan is an automatic payment plan made through your checking or savings account. Those choosing this plan will complete a FACTS agreement form to authorize the automatic monthly payments on either the 5th or the 20th of each month. There is yearly fee per family to set up payments with FACTS.
