# 1 TUITION PACKET FACT SHEET

## 1.1 Tuition and Enrollment Periods

Tuition for the 2012-2013 School Year is as follows:

\$3600	Kindergarten	(8:30 AM – 12 Noon)
\$4700	First- Eighth Grades	(8:30 AM – 3:05 PM) (7 <sup>th</sup> & 8 <sup>th</sup> ends @ 3:10 PM)

Tuition, books, and other materials are included in the listed tuition price.

The **Enrollment Period** for the 2012-2013 School Year begins on **January 4, 2012**.

## 1.2 Enrollment Fee and Tuition Down Payment:

### ▪ Per Family Enrollment Fee:

Note: *The Enrollment fee is per family and not per student.*

- *The Early Bird Rate is \$175 if paid by January 31 and will be applied to the tuition balance.*
- *The Regular Rate is \$250 if paid from February 1 - March 30.*
- *Rate is \$325 if paid after March 30.*

### ▪ Tuition Down Payments (per student)

- 10% of Tuition, after Student Discounts, plus Enrollment Fee

Note: *Tuition down payments and enrollment fees are non-refundable.*

## 1.3 Tuition Discounts:

- Only one of the two following discounts apply:
- **Family-Friendly-Multiple-Child Discount:** A tuition discount is available to families with more than one child enrolled in Grace Christian Academy. The child in the highest grade will be enrolled at full tuition, then a **30% tuition discount** is applied to each additional child enrolled during the same school year.
- **Full-time-Christian-Worker Discount:** A **25% tuition discount** will be given to families with at least one parent/guardian employed as a full-time Christian worker. A “full-time Christian worker” is defined as one who is employed full time by a recognized Christian organization. This discount is specifically created for full-time pastors of Christian churches and full-time Christian missionaries. This discount may be applied to other full-time Christian workers as approved by the Grace Christian Academy School Board.

## 1.4 Tuition Payment Plan Options:

Grace Christian Academy offers two payment plan options. Note: Payment plan options are to be declared at the time of enrollment.

- A. **Pay-in-Full Option:** Pay the full account balance directly to Grace Christian Academy prior to the first day of instruction.

**Early-Pay-in-Full Discount:** A **\$100 Discount** per student will be given to those who pay the entire year’s tuition **on or before June 30th**. This payment is made directly to Grace Christian Academy; this discount is applied separately to the total balance after other discounts are applied.

- B. **Monthly Payment Option:** The account balance is paid monthly over a ten (10) month period beginning in August via the FACTS Tuition Management Program. This option is an automatic payment plan made through your checking or savings account. Those choosing this option will complete a FACTS Agreement Form to authorize the automatic monthly payments on either the 5th or the 20th of each month. There is a \$38 yearly fee per family to set up payments with FACTS.

\_\_\_\_\_ **Option 1 Payment-in-Full:** Make a single payment of the unpaid balance directly to Grace Christian Academy. Pay in full by June 30, 2012 to receive a \$100 discount per student on the tuition total.

*\*Discount is voided if payment is not received by June 30, 2012.*

\_\_\_\_\_ **Option 2 10 Monthly Payments beginning in August 2012:** Automatic bank payments through your checking or savings account may be made on either the 5th or 20th of each month using FACTS. Complete the "FACTS Tuition Payment Agreement Form" and return it with your registration packet.

**Note: Full payment or acceptance in the FACTS Tuition Management Program (along with a tuition down payment and enrollment fee) is required before the student's first day of instruction.**
